

SCHOOL OF DENTAL SCIENCES (SDS)

(Admission Procedure for BDS Programme for the Academic Year 2017-18)

Fee Structure:

- BDS Course duration 4 years + 1 year internship
- BDS Course Fee Rs. 3,65,000/- payable annually
- Refundable Security Money (One Time) Rs. 50,000/-
- Registration, Medical check-up and Insurance (per annum) Rs. 37,500/-
- University Enrolment, Examination fee, etc. (per annum) Rs. 22,500/-
- **Hostel Fee:**
 - Refundable Hostel Security (One Time): Rs. 20,000/-
- **(For Girls):**
 - 2 seater AC room : Rs. 1,85,000/- per person, per annum
 - 4 seater AC room : Rs. 1,55,000/- per person, per annum
- **(For Boys):**
 - Single seater in Apartment (AC) : Rs. 1,90,000/- per person, per annum
 - Single seater in Apartment (Non-AC): Rs. 1,30,000/- per person, per annum

Note:

- All the Fees as detailed above are required to be paid in advance, at the time of admission, through Demand Drafts/ RTGS/ NEFT drawn in favour of Sharda University payable at Greater Noida.
- The payments must be made through Demand Draft/ RTGS/ NEFT only. Demand Draft should be in favor of **SHARDA UNIVERSITY**, payable at Greater Noida. RTGS/NEFT may be made with the following details:
 - Account Holder : Sharda University
 - Bank Name & Address : State Bank of India, Greater Noida
 - Account Number : 32957609325
 - IFSC Code : SBIN0004324
 - Payment Proof of Fee : A copy of acknowledgement from Bank/ UTR No. Bank statement showing RTGS/NEFT number need to be mailed at su.finance.info@sharda.ac.in along with NEET Students' Name, Father Name and NEET Roll Number)
- The University shall collect the fee and other expenses in July every year.
- If any amount has been deposited by the candidate with the DGME, Govt. of U.P., under the head of College fee, it shall be the responsibility of the candidate to get a certificate from the DGME that such amount shall be transferred to the account of the Sharda University; otherwise the said amount will have to be directly paid by the student, latest by 30th September, 2017.

- c. Documents relating to all the other higher education acquired after passing 10+2 and before admission to BDS Course.

- d. In case of a gap between 10+2 Examination & BDS Admission, an Affidavit to this effect on a non Judicial Stamp Paper of Rs.10/-, duly notarized.
- e. Migration Certificate, Transfer Certificate.
- f. Admit Card – NEET 2017.
- g. Seat Allotment Letter received from the Counselling/down loaded from the Internet.
- h. Fifteen - Passport Size colored Photographs of student.
- i. One - Passport size colored photograph, each of Father, Mother and Local Guardian.
- j. Address Proof.
- k. Domicile Certificate.
- l. Caste Certificate – in case of SC/ST/OBC (Certificate must have been issued after 31.01.2017)
- m. Aadhar Card/ PAN Card
